



NO. 8 LIGHTING WARRANTY

Incandescent Fixture and Transformer Warranty

No. 8 Lighting Inc. warrants to the original purchaser that No. 8 Lighting Inc. products are free from material and workmanship defects for up to 5 years from the date of shipment.

At our option, we will repair or replace the defective fixture and/or transformer within the standard warranty period. This warranty applies only to the repair or replacement of the product and only when the product is properly handled, installed, and maintained according to our instructions.

This warranty excludes defects resulting from improper installation, acts of god, fire, vandalism, or other situations not related to our product.

Purchaser must notify No. 8 Lighting Inc. in writing within 60 days of noticing the defect. This warranty excludes field labor or service charges related to the repair or replacement of the product.

LED Fixture and LED Driver Warranty

No. 8 Lighting Inc. warrants to the original purchaser that No. 8 Lighting Inc. products are free from material and workmanship defects. All products listed on the Seller's website at the time of purchase (other than LEDs and Power Supplies) are warranted for a period of three (3) years from the original shipment date. All LEDs and Power Supplies listed on the Seller's website at the time of purchase are warranted for a period of five (5) years from the original shipment date. Products that are not listed on the Seller's website at the time of purchase (including any LEDs and/or Power Supplies) are warranted for a period of six (6) months from the original shipment date.

At our option, we will repair or replace the defective fixture and/or LED driver within the standard warranty period. This warranty applies only to the repair or replacement of the product and only when the product is properly handled, installed, and maintained according to our instructions.

This warranty excludes defects resulting from improper installation, acts of god, fire, vandalism, or other situations not related to our product.

Purchaser must notify No. 8 Lighting Inc. in writing within 60 days of noticing the defect. This warranty excludes field labor or service charges related to the repair or replacement of the product.

LED (emitter), Color Consistency, and Lumen Maintenance Warranty

No. 8 Lighting Inc. LED emitters fall under a 5 year warranty from date of shipment, based on standard operating conditions as specified in No. 8 Lighting instructions, as long as original purchaser has proof of purchase. "Failure" is considered a non-operating LED emitter or non-conformance to the following color consistency and/or lumen maintenance specifications:

1. Flux output >70% as compared to the product's performance as of the date of manufacture;
2. Color consistency between products in a population of luminaires in a single contiguous visual space viewable from any location within that space that differs less than 3 points in u', v' .

No. 8 Lighting Inc. shall investigate any non-conformity claims to determine whether the warranty is valid.

If the claim is determined to be valid, No. 8 Lighting Inc. will repair, or at our option, replace the defective emitter during the stated warranty period. This warranty excludes field labor or service charges related to the repair or replacement of the product.

THE FOREGOING IS THE ONLY OBLIGATION RELATING TO DEFECTIVE PRODUCTS AND IS IN LIEU OF ALL OTHER OBLIGATIONS OR WARRANTIES, EXPRESSED OR IMPLIED, ORAL OR WRITTEN, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT SHALL No. 8 LIGHTING INC. BE RESPONSIBLE FOR CONSEQUENTIAL, INCIDENTAL, INDIRECT OR SPECIAL DAMAGES OF ANY KIND.
